APPLICATION FOR BOARD OF DIRECTORS

By-laws Regarding Board of Directors

Article III. Section C

The Board of Directors (hereinafter referred to as Board) shall have charge of all matters pertaining to the Articles of Incorporation or documents of legal organization, church property, and physical and financial affairs of the church. The Board is accountable for managing the collection and disbursal of funds, maintenance of the church records, managing the cash flow and reporting to the Congregation and the UFMCC.

The Board shall consist of eight (8) members, elected for staggered terms, plus the Pastor (President) and Executive Director/Pastor (Moderator). Board members, excluding the Pastor (President) and Executive Director/Pastor (Moderator), must have been Members in Good Standing prior to their election and shall serve for a term of two (2) years. Board Members may serve not more than four (4) full terms consecutively. Consideration will be given to elect members with diverse perspectives, core competencies, and complementary skills consistent with the required functions and responsibilities of the Board. The Board may appoint a qualified person to serve on the Board until the next Congregational Meeting.

The Board shall meet at least once a month. Upon agreement of three (3) members of the Board, a special meeting may be called. All members must be notified, and the majority of active members must agree on a date and time. Special Board meetings may also be called by the Pastor (President) or Executive Director/Pastor (Moderator). The approved minutes of all Board meetings must be made available to the congregation upon request. The Board shall elect the corporate officers of Vice-Moderator, Clerk and the Treasurer and whatever other Board officers it deems appropriate.

You will be notified of your time slot prior to that date. If you have a scheduling conflict with that day or a specific time during that date, please advise when you return your application.
